

End User License Agreement (EULA)

Effective Date: 26-Apr-2025

This End User License Agreement ("Agreement") is a legal contract between you ("Licensee") and Elgibe Solutions SRL ("Licensor") regarding the use of the Blazor for Kids framework ("Software"). By installing, accessing, or using the Software, you agree to the terms outlined in this Agreement.

1. License Grant

- The Licensor grants Licensee a **non-exclusive, non-transferable, and revocable** license to use the Software in accordance with the selected subscription plan.
 - The Licensee may not sublicense, distribute, or resell the Software and assumes responsibility for any consequences arising from such actions.

2. Permitted Uses

Depending on the license type purchased, the Licensee is permitted to:

- Use the Software for personal or commercial development, in accordance with the Terms and Conditions.
 - Modify the Software only for personal use, without the right to redistribute it; any consequences arising from unauthorized redistribution will be the user's responsibility.

3. Restrictions

The Licensee agrees **not** to:

- Copy, distribute, or resell the Software without Licensor's prior written permission.
 - Reverse-engineer, decompile, or attempt to derive the source code; any consequences arising from such actions will be the user's responsibility. Use the Software for illegal or unauthorized purposes, in which case the company is absolved of any liability.

4. Ownership



- The Licensor retains all intellectual property rights to the Software, without exception.
 - The Licensee acquires no ownership rights and only a limited right to use the Software, as outlined in the Terms and Conditions set by the Licensor.

5. Subscription & Termination

- The license is valid for the duration of an active subscription.
 - If the subscription expires or is terminated, the Licensee must stop using the Software and delete all copies.
 - The Licensor may revoke the license if Licensee violates this Agreement.
 - The Licensor reserves the right to terminate the license prematurely if the Licensee violates any material terms of this Agreement, the Terms of Service, the Privacy Policy, or engages in actions that significantly harm the platform or the company's interests.

6. Warranty Disclaimer

- The Software is provided "as is" without warranties of any kind.
 - The Licensor does not guarantee uninterrupted or error-free operation.

7. Limitation of Liability

- The Licensor is not liable for any indirect, incidental, or consequential damages arising from the use of the Software.
 - Liability is limited to the amount paid for the subscription in the last 12 months.

- This Agreement is governed by the laws of Romania.



- Any disputes shall be resolved through arbitration at The International Commercial Arbitration Court attached to the Cluj Chamber of Commerce and Industry.

- The Licensor reserves the right to update this Agreement at any time.
- Continued use of the Software after an update constitutes acceptance of the new terms.
